<p>Businesses and camps often like to put signs, advertisements, or art in their windows, but it's important not to obstruct the view to the exterior. It is recommended that signs take up no more than 10% of window space.</p>

<p>It is important for shrubs to be regularly trimmed to avoid creating hiding spaces.</p>

<p>A person leaving a location should be able to locate their car before exiting the building. This is particularly important at night so that they can see they have an unobstructed path to their car.</p>

<p>Parking areas and exterior walkways should be lit at night enough so that you can identify a person from at least 25 feet away.</p>

<p>Defining spaces naturally helps to discourage trespassing and create a sense of ownership among people that should be there.</p>

<p>Camp and park property may be stolen if left unattended at night. <b>46. Do all exterior doors have deadbolt locks?</b>  A deadbolt lock with a beveled cylinder guard prevents removal with pliers or a pipe wrench. The deadbolt should be used in addition to the handle lock. <b>48. Can all doors be securely locked?</b>  All exterior doors, porch doors, sliding doors, and balcony doors must be securely locked.
