Overview: For the second year, the Flint River Council is producing a discount card called the CAMP CARD. Sales of the CAMP CARD will assist Scouts in earning their own way to summer camp. Attendance in Scout summer camp is the number one reason Scouts stay active in Scouting; the longer Scouts stay active, the greater opportunity they have to learn life changing values.

Dates: Cards will be sold for \$5.00 by Scouts from March 1 – May 31, 2011. Discounts should be valid from March 1, 2011 to December 31, 2011.

Quantity: We plan to produce a total of 80,000 cards in Fayette, Coweta, Spalding, Butts, Lamar, Pike, Upson, & Henry counties in Georgia. Last year we sold 35,000 cards. For 2011, we are producing 5 regional cards, our sales expectations by county are below.
