


When collecting information for the Voice of the Scout, there are two key elements to the surveys:

1) The NPS Question- A Measurement of Loyalty

2) Driver Questions- Measures the Value Experience

people have with Scouting



The driver questions are tailored based on the varying expectations of each audience group. The initial set of questions was determined through independent research in the field done in Spring/Summer 2011 and will continue to be updated as needed.

Additionally, the driver questions have been developed to give strategic insight into performance in Programs, Leadership, Activities and Operations. By understanding how we are delivering in these areas, the intent is to bring focus into areas needing improvement, thus making management decisions in these areas more impactful.
