ADVISORY COUNCIL

"There shall be an advisory council to the regional board composed of:

- A. All members of the regional board and former members of the regional executive committee of not less than five years who may attend regular meetings of the Region, but will not have a vote at or during the meeting of the board, but may continue their relationship in an advisory or consulting capacity; and
- B. Elected Advisory Board members, who, because of experience have a particular expertise that would benefit the movement through the region and are elected to membership on the advisory council by a two-thirds vote of the members of the regional board present at any meeting."
